



I. INTRODUCTION

The RICON RD02500 Series Power Sliding Door Operator opens and closes sliding van doors. It has been designed to operate in most full-size vans, and works in conjunction with Ricon S-Series, Spirit, and UNI-lite wheelchair lifts.



The power door operator is electrically connected to and operated with the controls of the wheelchair lift. As the lift is activated to DEPLOY/OUT, or extend from the vehicle, the power door operator automatically opens the vehicle door to allow the lift to deploy. After the lift has been used and is activated to STOW/IN and retract into the vehicle, the door operator automatically closes the vehicle door.

This manual contains warranty information, operation and maintenance instructions for the Power Door Operator. It is important that operator(s) be completely familiar with the operating instruction. For installation instructions, please refer to the service manual. Once the Door Operator is installed, it is very important that it be properly maintained by following the Ricon recommended maintenance schedule.

Ricon Corporation (Ricon) warrants to original purchaser of this product that Ricon will repair or replace, at its option, any part that fails due to defective material or workmanship as follows:

• Repair or replace parts for a period of one year from date of purchase. A complete list of parts covered by this warranty can be obtained from an authorized Ricon dealer.

If You Need to Return a Product: Return this Ricon product to your installing dealer. Please give as much advance notice as possible and allow a reasonable amount of time for repairs.

If You are Traveling: All authorized Ricon dealers honor this warranty. Consult telephone directory, or call our Product Support department for the name of nearest authorized Ricon dealer.

This Warranty does not Cover:

- Labor or service charges (these may be covered separately by the installing dealer).
- Malfunction or damage to product parts caused by accident, misuse, lack of proper maintenance, neglect, improper adjustment, modification, alteration, the mechanical condition of vehicle, road hazards, overloading, failure to follow operating instructions, or acts of Nature (i.e., weather, lightning, flood).

Note: Ricon recommends that this product be inspected by an authorized Ricon service technician at least once every six months, or sooner if necessary. Any required maintenance should be performed at that time.

Ricon assumes no responsibility for expenses or damages, including incidental or consequential damages. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply.

Important: The warranty registration card must be completed and returned to Ricon within 20 days after installation of this Ricon product for the warranty to be valid. The warranty is not transferable.

The warranty gives specific legal rights, and there may be other rights that vary from state to state.

B. SHIPMENT INFORMATION

Ricon does not sell directly to the user because of the specialized nature of this product. The product is distributed through a worldwide network of authorized Ricon dealers who perform actual installation.

Be sure the installation kit contains all items listed on the kit packing list. Please report any missing items immediately to Ricon Product Support. The warranty and owner registration cards must be completed and returned to Ricon within 20 days for the warranty to be valid.

The Sales/Service Personnel must review Warranty and this Owner Manual with user to be certain that they understand safe product operation. Instruct the user to follow operating instructions without exception.

C. GENERAL SAFETY PRECAUTIONS

The following general safety precautions must be followed during installation, operation, service, and maintenance:

- Avoid injury. Exercise caution when operating, and be certain that hands, feet, legs, and clothing are not in the path of door or product movement.
- Read and thoroughly understand the operating instructions before attempting to operate.
- Inspect the product before each use for any unsafe condition. If an unusual noise or movement exists, do not use door operator until the problem is corrected.
- Keep others clear during operation.
- The product requires periodic maintenance. A thorough inspection is recommended at least once every six months. The product should be maintained at the highest level of performance.

D. PRODUCT TERMINOLOGY




FIGURE 1-1: RD02500 SERIES POWER OPERATOR REFERENCE

The references used throughout this manual are illustrated in **Figure 1-1** and defined in **Table 1-1**. Refer to Service Manual, Chapter IV, "Parts and Diagram Lists" for more details.

II. OPERATING INSTRUCTIONS

This chapter contains safety precautions, daily safety check instructions, control and indicator descriptions, and operating instructions for the RICON RD02500 Series Power Sliding Door Operator. This chapter must be read and thoroughly understood by the operator before attempting to use the power door operator.

<u>NOTE</u>: The Operating Instructions chapter of the applicable Ricon S-Series or UNI-lite Wheelchair Lift Operator Manual must also be read and understood.

A. SAFETY PRECAUTIONS

Refer to Figure 2-1. A hazardous situation may exist when using the lift if the vehicle is parked on either a side or front-to-rear slope. Operate the door operator with the vehicle parked on level ground.

- Vehicle must be safely parked with the engine turned off before using the door operator.
- Inspect the power door operator prior to each use. If unusual noises or movements exist, DO NOT use and contact an authorized Ricon service technician for repair.
- Do not place arms, legs, or clothing in or near moving parts.
- Keep others clear while operating.
- Do not allow an untrained person to operate.
- Exercise supervision if used by or near children.
- Never leave the lift outside of vehicle and the vehicle door open. Always return lift to stowed position and allow the power door operator to close the vehicle door after use.

Be sure that these safety precautions have been read and understood. Review them periodically, and ask any attendants or other operators to read them as well. If there are any questions, contact an authorized Ricon dealer or call Ricon Product Support.

B. DAILY SAFETY CHECK

Inspect the power door operator prior to each use and check that the following conditions are met before operating:

- All functions operate properly. If unusual noise or movement is present, DO NOT use and contact an authorized Ricon dealer for repair.
- No objects are present that may interfere with operation.
- General appearance and lubrication are satisfactory.
- All fasteners are tight.

C. CONTROLS AND INDICATORS


The power door operator is electrically connected to and operated with the controls of the Ricon wheelchair lift or ramp. As the lift or ramp is activated to DEPLOY, or extend from the vehicle, the power door operator automatically opens the vehicle door. After the lift or ramp has been used and is activated to STOW, the lift or ramp retracts into the vehicle and the door operator automatically closes the door.

Refer to the appropriate Ricon wheelchair lift or ramp manual for detailed door operator control and indicator descriptions.

If so equipped, the door operator may also be controlled with a dash-mounted, momentary toggle switch. Maintain pressure on the switch in the appropriate direction until the vehicle door is either fully closed or fully opened. Refer to the appropriate Ricon Wheelchair Lift or Ramp Operator manual and follow the operating instructions carefully.

D. LIFT OR RAMP CONTROL PENDANT

Refer to **Figures 2-2** and **2-3**. The power door operator is electrically interfaced with and automatically controlled by the Ricon wheelchair lift or ramp control pendant. The control pendant is a hand-held, hard-wired remote device that also controls the door operator or ramp functions. The pendant has two rocker switches to control functions, and is mounted on a wall-clip inside the vehicle (near the door opening). To perform the desired function, push and hold the appropriate switch until the function is completed.



E. ELECTRICAL CONTROLS AND INDICATORS



1. POWER DOOR OPERATOR CIRCUIT BREAKER

Refer to **Figures 2-4** through **2-6**. The power door operator circuit breaker is located on either the S-Series hydraulic pump enclosure or the Spirit or UNI-lite electrical box. In the event of a short circuit, the circuit breaker button will pop-up; press to reset. **Do not press and hold** if pressing and releasing the button does not restore power. Contact an authorized Ricon dealer for repair.




FIGURE 2-6: SPIRIT POWER DOOR OPERATOR CIRCUIT BREAKER

2. LIFT OR RAMP MAIN CIRCUIT BREAKER




FIGURE 2-7: DOOR OPERATOR MAIN **CIRCUIT BREAKER**

Refer to Figures 2-7 and 2-8. The door operator or ramp main circuit breaker is located in the vehicle engine compartment and is designed to interrupt electrical power to the door operator or ramp electrical system in case of a short circuit. In the event of a short circuit, the circuit breaker reset tab or button will "swing-down" or "pop-out. Press to reset. Do not press and hold if pressing and releasing the button does not restore power. Contact an authorized Ricon dealer for repair.

F. POWER DOOR OPERATION

\land WARNING!

- Before operating the power door operator and lift or ramp, be certain vehicle is safely parked on a level area away from traffic. Allow enough space for operation and passenger boarding.
- Be certain vehicle safety interlock mechanism (e.g., emergency/power brake) is properly engaged before attempting to operate the lift (or ramp). The lift (or ramp) will not operate until the safety interlock function has been engaged.
- Take special care to ensure the area is clear before deploying the lift (or ramp).

\land WARNING!

ATTENDANT MUST REMAIN IN CLOSE PROXIMITY TO PASSENGER TO RENDER IMME-DIATE ASSISTANCE, IF NECESSARY. KEEP OTHERS CLEAR WHEN OPERATING DOOR OPERATOR. MAINTAIN PRESSURE ON SWITCH UNTIL FUNCTION IS COMPLETE.

If the vehicle is equipped with a dash-mounted, momentary toggle switch for the door operator, maintain pressure on the switch until the vehicle door is either fully closed or fully opened. Refer to the appropriate Ricon Operator manual and follow the operating instructions carefully.

If the vehicle is not equipped with a dash-mounted, momentary toggle switch for the door operators, follow the instructions below:

1. ENTER VEHICLE

- a. **OPEN DOORS and DEPLOY PLATFORM (OR RAMP)** Press and hold control pendant DEPLOY/STOW switch in the DEPLOY position until the doors open and the platform fully deploys and stops automatically at vehicle floor level (or the ramp fully deploys).
- b. **LOWER PLATFORM -** Press and hold the UP/DOWN switch in the DOWN position until the platform reaches ground level and the outer rollstop opens completely.

- c. Carefully place wheelchair centrally on platform, facing outward, and LOCK WHEELCHAIR BRAKES. Be certain wheelchair is properly positioned on platform; it must not contact outer rollstop and prevent it from locking as the platform rises.
- d. **RAISE PLATFORM -** Press and hold the UP/DOWN switch in the UP position until the platform rises and stops automatically at the vehicle floor level.
- e. **STOW PLATFORM (OR RAMP) and CLOSE DOORS** Press and hold the DE-PLOY/STOW switch until the platform (or ramp) fully stows and the doors close completely.

2. TO EXIT VEHICLE:

- a. **OPEN DOORS and DEPLOY PLATFORM (OR RAMP)** Press and hold control pendant DEPLOY/STOW switch in the DEPLOY position until the doors open and the platform fully deploys and stops automatically at the vehicle floor level (or the ramp fully deploys).
- b. **EXIT VEHICLE FACING OUTWARD.** Be certain platform is safely at vehicle floor level and platform rollstop is in an up and locked position.
- c. **LOWER PLATFORM -** Press and hold the UP/DOWN switch in the DOWN position until the platform reaches ground level and the outer rollstop opens completely.
- d. Release wheelchair brakes and carefully exit platform.
- e. **RAISE PLATFORM -** Press and hold the UP/DOWN switch in the UP position until the platform rises and stops automatically at the vehicle floor level.
- f. **STOW PLATFORM (OR RAMP) and CLOSE DOORS** Press and hold the DE-PLOY/STOW switch until the platform (or ramp) fully stows and the doors close completely.

3. MANUAL OPERATION

In the event the power door operator becomes inoperable under its own power, it can be operated manually.

🔥 WARNING!

DO NOT REMOVE THE EMERGENCY RELEASE PIN WHILE VEHICLE IS IN MO-TION, AS DOORS CAN OPEN, CREATING A HAZARDOUS SITUATION FOR PAS-SENGERS. DO NOT ALLOW CHILDREN TO PLAY WITH THE RELEASE PIN.




FIGURE 2-9: EMERGENCY RELEASE PIN

- a. Refer to **Figure 2-9**. Pull the Emergency Release Pin UPWARDS through the anchor bracket.
- b. Push doors open to clear path of platform (or ramp).
- c. Refer to the lift Operator Manual for lift operating instructions.

III. MAINTENANCE

R egular routine maintenance of the RICON RD02500 Series Power Sliding Door Operator is required to provide optimum performance. During the Ricon warranty period, maintenance inspections must be performed by an authorized Ricon service technician at least once every six months, or sooner depending on usage. After the warranty period, it is recommended that maintenance inspections be continued at the same time intervals.

CAUTION!

This Ricon product is highly specialized. Maintenance must be performed by an authorized Ricon service technician using Ricon replacement parts. Modifying or failing to properly maintain this product may void the warranty and result in unsafe operating conditions. To maintain the warranty, this product must be inspected at least every six months, or sooner depending on usage.

C. TROUBLESHOOTING GUIDE

The troubleshooting guide is designed to provide a logical starting point to locate general problems that could occur with the lift. However, not all possible problems or combinations of problems are listed. For trouble shooting the door operator, refer to **Table 3-2**. The guide does not incorporate routine safety precautions or preliminary procedures and assumes that the vehicle battery is fully charged and the battery terminals/connectors are clean and tight.

WARNING!

THE TROUBLESHOOTING GUIDE DOES NOT INCORPORATE ROUTINE SAFETY PRECAUTIONS OR PRELIMINARY PROCEDURES. DURING THE RICON WARRANTY PERIOD A TRAINED, AUTHOR-IZED RICON SERVICE TECHNICIAN MUST PERFORM TROUBLESHOOTING. AFTER THE WAR-RANTY PERIOD, IT IS RECOMMENDED THAT TROUBLESHOOTING CONTINUE TO BE PERFORMED BY AN AUTHORIZED RICON SERVICE TECHNICIAN.
