

I. INTRODUCTION

T he RICON RD03000 Series Internal Power Swing Door Operators electrically open and close swing-type van doors. They have been designed to operate in most full size vans and provide up to 90° of motion for each door. The power door operators are installed within the doors. Adjustable rod ends provide smooth operation, and splined connections between the crank-arm and the motor output shafts provide wobble-free operation.



The power door operators work with wheelchair lifts and ramps. Before the platform or ramp is deployed (extended from the vehicle) the power door operators automatically unlatch and open the vehicle doors. After the platform or ramp has been used and is stowed and retracted into the vehicle, the door operators automatically close and latch the vehicle doors. The power door operators are installed onto two doors but for safety reasons only one door is allowed to operate at a time. The vehicle doors must be unlocked before using the power door operators.

This manual contains operating instructions, a maintenance schedule and brief troubleshooting instructions for the power door operators. For installation instructions, please refer to service manual 32DD0302. It is important to user safety that the installation is thorough and correct. Once the operators are installed, it is very important that they be properly maintained by following the Ricon-recommended cleaning, lubrication, and inspection instructions.

B. SHIPMENT INFORMATION

Ricon does not sell directly to the user because of the specialized nature of this product. The product is distributed through a worldwide network of authorized Ricon dealers who perform actual installation.

- When the product is received, unpack it and check for freight damage. Claims for any damage should be made to freight carrier immediately.
- Be sure installation kit contains all items listed on kit packing list. Please report any
 missing items immediately to Ricon Technical Support. The warranty and owner's registration cards must be completed and returned to Ricon within 20 days for the warranty to
 be valid.

NOTE: The Sales/Service Personnel must review the Warranty and this Operator Manual with user to be certain they understand the safe operation of product. Instruct the user to follow operating instructions without exception.

C. GENERAL SAFETY PRECAUTIONS




FIGURE 1-1: RD03000 SERIES INTERNAL POWER DOOR OPERATOR (RIGHT SIDE DOOR SHOWN IN OPEN POSITION; LEFT DOOR INSTALLATION IS OPPOSITE)

II. OPERATING INSTRUCTIONS

This chapter contains safety precautions, daily safety check instructions, control and indicator descriptions, and operating instructions for the RICON RD03000 Series Internal Power Swing Door Operator. This chapter must be read and thoroughly understood by the vehicle operator before attempting to use the power door operator.

A. SAFETY PRECAUTIONS




FIGURE 2-1: DO NOT DEPLOY LIFT WHEN VEHICLE IS ON SLOPED GROUND

Refer to Figure 2-1. A hazardous situation may exist when using the platform or ramp if
the vehicle is parked on either a side or front-to-rear slope. Operate the platform or ramp
with the vehicle parked on level ground.

- Vehicle must be safely parked with the engine turned off before using the platform or ramp.
- Inspect the power door operators prior to each use. If unusual noises or movements exist, DO NOT use and contact an authorized Ricon service technician for repair.
- Do not place arms, legs, or clothing in or near moving parts.
- Keep others clear while operating.
- Do not allow an untrained person to operate.
- Exercise supervision if used by or near children.
- Never leave the platform or ramp outside of vehicle and the vehicle door open. Always return platform or ramp to stowed position and allow the power door operators to close the doors after use.

Be sure that these safety precautions have been read and understood. Review them periodically, and ask any attendants or other vehicle operators to read them as well. If there are any questions, contact an authorized Ricon dealer or call Ricon Product Support.

B. DAILY SAFETY CHECK

Inspect the power door operators prior to each use and check that the following conditions are met before operating:

- All functions operate properly. If unusual noises or movements exist, DO NOT use and contact your Ricon dealer for repair.
- No objects that may interfere with operation are present.
- General appearance and lubrication are satisfactory.

C. CONTROLS AND INDICATORS

The power door operators are electrically connected to and operated with the controls for the Ricon wheelchair platform or ramp. Before the platform or ramp is deployed, or extended from the vehicle, the power door operators automatically unlatch and open the vehicle doors. After the platform or ramp has been used and is stowed and retracted into the vehicle, the door operators automatically close and latch the vehicle doors. The vehicle doors must be unlocked before using the power door operators.

If so equipped, the door operators may also be controlled with a dash-mounted, momentary toggle switch.

1. PLATFORM OR RAMP CONTROL PENDANT




FIGURE 2-2: PLATFORM CONTROL PENDANT

Refer to **Figures 2-2** and **2-3**. The power door operators are automatically controlled by the platform or ramp control pendant. The control pendant is a hand-held, hard-wired remote device that controls platform or ramp functions. The pendant is typically mounted to a wall-clip inside the vehicle near the door opening. To operate the desired function, push and hold the appropriate switch in the labeled direction until the function is completed.




FIGURE 2-3: RAMP CONTROL PENDANT

CIRCUIT BREAKER LOCATIONS

a. Power Door Operator Circuit Breaker

CAUTION!

In the event of a short circuit, the circuit breaker button will pop up. If pressing and releasing the button does not restore power, **DO NOT PRESS AND HOLD**. Contact an authorized Ricon dealer for repair.




FIGURE 2-4: S-SERIES POWER DOOR OPERATOR CIRCUIT BREAKER





FIGURE 2-5: UNI-LITE POWER DOOR OPERATOR CIRCUIT BREAKER

The circuit breaker for the power door operators interrupts electrical power to the door operators in the event of a short circuit. If you use the Ricon S-series lift, the circuit breaker is located on the hydraulic power unit enclosure as shown in **Figure 2-4**. If you use the Ricon Uni-Lite series lift, the circuit breaker is located on top of the electrical box as shown in **Figure 2-5**. Press and release the circuit breaker to restore power to the door operators.

b. Platform Or Ramp Main Circuit Breaker




FIGURE 2-6: LIFT MAIN CIRCUIT BREAKER

The platform or ramp main circuit breaker is located in the vehicle engine compartment and interrupts electrical power to the platform or ramp electrical system if a short circuit occurs. In the event of a short circuit, circuit breakers equipped with a reset tab (shown in **Figure 2-6**) will rotate down; circuit breakers with a reset button (shown in **Figure 2-7**) will pop up. If pressing and releasing the reset tab or button does not restore power, **DO NOT PRESS AND HOLD**. Contact your authorized Ricon dealer for repair.

1. TO ENTER VEHICLE:

- OPEN DOORS AND DEPLOY PLATFORM OR RAMP Ensure that vehicle doors are unlocked. Press and hold control pendant DEPLOY button until the doors open and either the platform fully deploys or the ramp fully deploys.
- LOWER LIFT PLATFORM Press and hold the DOWN button until the platform reaches ground level and the outer rollstop opens completely.
- c. LOAD PLATFORM Carefully place wheelchair in center of platform, facing outward, and lock the wheelchair brakes. Be certain wheelchair is properly positioned on platform and does not contact outer rollstop, which may prevent it from locking as the platform rises.

- d. **RAISE LIFT PLATFORM** Press and hold the UP button until the platform rises and stops automatically at the vehicle floor level.
- e. **ENTER VEHICLE** Release wheelchair brakes and carefully enter vehicle.
- f. STOW PLATFORM OR RAMP AND CLOSE DOORS Press and hold the STOW button until the platform or ramp fully stows and the doors close completely.

2. TO EXIT VEHICLE:

- OPEN DOORS AND DEPLOY LIFT PLATFORM OR RAMP Press and hold control pendant DEPLOY button until doors open and either the platform fully deploys or the ramp fully deploys.
- b. LOAD PLATFORM Be certain platform is safely at vehicle floor level and platform rollstop is in an up and locked position. Carefully place wheelchair in center of platform, facing outward, and lock wheelchair brakes.
- LOWER PLATFORM Press and hold the DOWN button until the platform reaches ground level and the outer rollstop opens completely.
- d. **EXIT VEHICLE** Release wheelchair brakes and carefully exit platform.
- e. RAISE PLATFORM Press and hold the UP button until the platform rises and stops automatically at the vehicle floor level.
- f. STOW PLATFORM OR RAMP AND CLOSE DOORS Press and hold the STOW button until the platform or ramp fully stows and the doors close completely.

2. MANUAL OPERATION

In the event the power door operators become inoperable under their own power, they can be operated manually as follows:

- a. Remove the safety clips using the supplied quick release pin tool. The safety clips are located on the bottom of the quick release pins.
- Using the supplied quick release pin tool, pull the quick release pins UPWARD through the clevis brackets and rod ends. Save the pins for later reinstallation.
- c. Push doors open until they are clear of the platform or ramp path.
- d. Manually deploy the platform or ramp as shown in the Manual Operation section of the platform or ramp Operator Manual.

III. MAINTENANCE

Regular maintenance of the RICON RD03000 Series Internal Power Swing Door Operators will help provide optimum performance. During the Ricon warranty period, maintenance inspections must be performed at least once each six months, or sooner depending on usage. After the warranty period, maintenance inspections are recommended at the same time intervals.




FIGURE 3-1: DOOR OPERATOR DECALS
